INTRODUCTION

PURPOSE OF THIS GUIDE

This guide has been produced to assist the candidate chief financial officer (CFO) with the preparation of financial disclosure forms including the campaign return, the deficit retirement period financial statement, and all applicable schedules.

This guide is intended to be used in conjunction with the Party, Constituency Association and Candidate Guide to the Election Finances and Contributions Disclosure Act. All guides, registration and financial disclosure forms are available on the Elections Alberta website at www.elections.ab.ca.

Links to the *Election Finances and Contributions Disclosure Act* (EFCDA) and other relevant legislation are also available on the Elections Alberta website. Copies of provincial legislation may also be obtained from the Alberta Queen's Printer (www.qp.alberta.ca).

PUBLIC DISCLOSURE

All documents, including financial statements and registration documents, required to be filed with Elections Alberta by a candidate become part of the public files and are available for public review. Financial statements are also posted on the Elections Alberta website at www.elections.ab.ca under Parties, Candidates & Contests / Financial Disclosure.

CAMPAIGN RETURN

This section contains information to assist the CFO to prepare the campaign return. Under section 43(2) of the EFCDA, the campaign return must include a financial statement, contribution report, campaign expense report, an expense limit report and any supporting information or documents relating to the candidate’s campaign return. The following step-by-step instructions are for the Candidate Campaign Period Financial Statement form **CD-FS-01**.

 - Enter amount of the transfer
- Sum total transfers issued and enter amount on line 21 of the financial statement (CD-FS-01)

► **Other Income CD-FS-S03**

- For other income received that has not been reported on lines 1 to 8 of the financial statement:
 - Enter date the income was received
 - Enter source of the income
 - Enter nature of the income
 - Enter amount of the income
- Sum total other income and enter amount on line 9 of the financial statement (CD-FS-01)

Note: “Other Income” may include:

- anonymous valued or money amounts received of \$50 or less
- collections from general meetings (the gross amount not reduced by expenses)
- interest earned on investments and/or bank deposits
- selling price of any goods and services sold (e.g. pins, buttons, etc.)
- any other funds collected of \$50 or less for which contribution receipts were **not** issued

► **Accounts Receivable CD-FS-S07**

- For any amounts owed to the candidate's campaign and not yet received as at the end of the campaign period:
 - Enter date the receivable was incurred by the debtor (the individual, organization, or business owing the amount)
 - Enter name of the debtor
 - Enter brief description of the receivable
 - Enter amount of the receivable
- Sum total accounts receivable and enter amount on line 29 of financial statement (CD-FS-01)

► **Other Assets at Cost CD-FS-S08**

- For other assets of the candidate's campaign that have not been reported on lines 27 to 30 of the financial statement:
 - Enter date the asset was acquired / received
 - Enter brief description
 - Enter purchase price / value of the asset
- Sum total other assets and enter amount on line 31 of the financial statement (CD-FS-01)

Note: Examples of other assets may include membership shares in a credit union, contributions received but not yet deposited, or election goods to be re-used at a future election.

► **Terms and Details of Loans CD-FS-S09**

- Enter total number of loans
- Enter total amount owing on all outstanding loans as at the end of the campaign period, and enter the amount on line 33 of the financial statement (CD-FS-01)
- For each loan:
 - Enter name and address of the lender
 - Enter original loan amount
 - Enter total interest accrued to date
 - Enter total payments made
 - Enter current balance owing
 - Enter terms
 - Enter guarantor details including amount(s) guaranteed, guarantor name(s) and address(es)
 - Enter payment details including date(s) and amount(s) paid, payer name(s) and address(es)

Note: See [Party, Constituency Association and Candidate Guide to the EFCDA](#) for more information regarding loans from financial institutions.

► **Accounts Payable CD-FS-S10**

- For any invoices from suppliers that were not yet paid by the candidate's campaign as at the end of the campaign period:
 - Enter date of the invoice
 - Enter name of the supplier
 - Enter brief description the good or service
 - Enter amount of the invoice
- Sum total accounts payable and enter amount on line 34 of the financial statement (CD-FS-01)

► **Debts Incurred But Not Yet Billed CD-FS-S11**

- For any debts owing to suppliers that were not yet billed (invoiced) as at the end of the campaign period:
 - Enter date the debt was incurred
 - Enter name of the supplier
 - Enter brief description of the good or service
 - Enter amount owed / yet to be billed (invoiced)
- Sum total debts incurred but not yet billed and enter amount on line 35 of the financial statement (CD-FS-01)

► **Other Liabilities CD-FS-S12**

- For any liabilities (financial obligations) that were outstanding as at the end of the campaign period and have not been reported on lines 33 to 35:
 - Enter date the liability was incurred
 - Enter name of the supplier
 - Enter brief description
 - Enter amount of the liability
- Sum total other liabilities and enter amount on line 36 of the financial statement (CD-FS-01)

DEFICIT RETIREMENT PERIOD (DRP) FINANCIAL STATEMENT

This section contains information to assist the CFO to prepare the deficit retirement period financial statement (amended campaign return), when there is a deficit position at the end of the candidate’s campaign. Under section 43.1 of the EFCDA, any contributions accepted and any transfers received to eliminate the campaign deficit must be shown. The following step-by-step instructions are for the Candidate Deficit Retirement Period Financial Statement form **CD-DS-01**.

► HEADER INFORMATION

- Enter deficit retirement period date range, starting with day *after* the filing deadline for the candidate financial statement, and ending three months after that date or six months if an extension was granted.
- Enter name of the registered candidate, name of the registered political party, and name of the electoral division
