Message from the Chief Electoral Officer

The 2012 calendar year was a very busy one for Elections Alberta and for the hundreds of volunteers and staff members associated with political entities who worked hard to fulfill their responsibilities under the *Election Finances and Contributions Disclosure Act*. In addition to the annual financial statements submitted by political parties, a record number of financial statements were submitted by constituency associations on old and new electoral division boundaries and over four hundred campaign statements were submitted on behalf of candidates and political parties for the Provincial General Election and the Senate Nominee Election.

The 2012 calendar year saw two new filing requirements. Candidates reporting deficits on their campaign financial statements reported on the retirement of those deficits, to ensure full disclosure of all contributions used to fund their campaigns. Third parties also submitted financial statements to provide Albertans with a complete picture of persons and organizations that funded political advertising in the election period. The principles of openness and transparency, evident in the recent legislative amendments, were the focus of this Office in the 2012 calendar year.

As always, Elections Alberta demonstrated its strong commitment to compliance through education by the development and distribution of educational resources, as well as through support offered to political entities. In addition, legislative amendments expanded the remedies available to the Chief Electoral Officer to allow for more effective enforcement and disclosure of the results of violations.

While the 2012 calendar year required the review and follow-up of over 1,200 financial statements, planning and preparation for the implementation of legislative amendments enacted late in the year was another key priority. One new challenge was the management of quarterly reporting requirements, which involved ongoing stakeholder communications, online system development, educational resource development, ongoing user support and the consolidation of stakeholder input. The successful implementation of the quarterly reporting system was largely due to the automation of educational and filing processes. In future, we hope to leverage this success to facilitate support and compliance within the broader framework of financial filing.

This report represents hundreds of hours of diligent effort on the part of Elections Alberta staff. The wealth of information contained in these pages is a credit to the staff and volunteers of political entities who were responsible for the ongoing management of political finances, and the preparation and submission of over 1,200 financial statements that are summarized in the pages of this report. The comprehensive information is a tribute to all those involved, and particularly to the shared commitment to compliance and disclosure of financial activities for the 2012 calendar year.

Section One – The 2012 Calendar Year

Overview

The following are some of the major activities and events that occurred during the calendar year:

- Writs of election were issued on March 26, 2012 for the 2012 Provincial General Election and the 2012 Senate Nominee Election. Detailed financial information on the conduct of the elections was published in the Chief Electoral Officer's Report on the 2012 Provincial General Election and the 2012 Senate Nominee Election. Information on registrations, contributions and expenses of nine political parties, 431 General Election candidates, thirteen Senate Nominee candidates, and five third parties are contained in this annual report.
- Boundaries of 87 new electoral divisions came into effect on March 26, 2012 with the issuance of the writs for the 2012 Provincial General Election. At the same time, boundaries of the 83 old electoral divisions were dissolved. At that time, the 383 constituency associations registered on the old boundaries were no longer constituted and political parties were required to register constituency associations on the new boundaries. In total, 382 constituency associations were registered on the new boundaries as at December 31, 2012. Annual financial statements for the 2012 calendar year were required to be filed on both the old and new boundaries. Information on registration and contributions for all constituency associations are contained in this annual report.
- The Evergreen Party of Alberta (EPA) made application to the Chief Electoral Officer to change the name to Green Party of Alberta (GPA). The request was approved effective November 1, 2012. The political party is identified in this report by the name and abbreviation as at December 31, 2012.
- Four new third parties were registered during the 2012 calendar year.
- Bill 7, the *Election Accountability Amendment Act* (the *Act*), received Royal Assent on December 10, 2012. While the *Act* amended the *Election Act*, *Election Finances and Contributions Disclosure Act* (the *EFCD*) and the *Senatorial Selection Act*, the amendments to the *EFCD* had immediate and significant impact on political parties and constituency associations. Highlights on amendments to the *EFCD* are contained in Section Five of this annual report.

Registration Information

Reserved Political Party Names

This Office held one reserved political party name on file as at December 31, 2012. The applicant has proposed to form a registered political party in accordance with the provisions of the *EFCDA*. The applicant has been advised that one of the primary requirements for registration is the completion of a petition under Section 6(2)(d) of the *EFCDA*. The petition must contain a minimum of 7,163 signatures of eligible electors, which represents 0.3% of the number of electors eligible to vote at the 2012 Provincial General Election.

On March 26, 2012, when the writs were issued for the 2012 Provincial General Election, the new electoral division boundaries prescribed by the *Electoral Divisions Act* were proclaimed into effect and constituency associations were formed on the new boundaries.

From March 26 to December 31, 2012 there were 382 applications for registration of constituency associations received and approved on the new electoral division boundaries. A chart showing the registration status of constituency associations of each political party, by electoral division as at December 31, 2012, is presented on pages 18 and 19.

Deregistrations

All 383 constituency associations registered on the old electoral division boundaries were deregistered on March 26, 2012.

Reregistrations

Financial Statement Information

In accordance with Section 42 of the *EFDA*, political parties and constituency associations registered prior to September 1, 2012 were required to file annual financial statements with the Chief Electoral Officer on or before March 31, 2013.

The following represents the number, monetary amount, and category of contributions received by political parties and constituency associations in the 2012 calendar year as represented by the contribution receipts issued. Figures in this report are rounded to the nearest dollar.

Political Parties – Annual Financial Statements

Nine political parties were registered with the Office of the Chief Electoral Officer as at December 31, 2012. All were required to submit a 2012 Political Party Annual Financial Statement on or before March 31, 2013 and all submitted by the filing deadline. The political parties were:

Audited financial statements are required if the revenue or expenses of a political party exceed \$1,000 for the reporting period. All political parties, except the Communist Party – Alberta, submitted audited financial statements.

Foundations

In accordance with Section 6(6) of the *EFDA*, political parties that maintain a foundation are also required to file an annual report of the expenditures of that foundation. As at December 31, 2012, only the Progressive Conservative Association of Alberta maintained a foundation and it reported expenditures of \$14,984.

- 343 constituency associations filed their financial statements by the filing deadline;
- 30 constituency associations filed their financial statements after the filing deadline; and
- 10 constituency associations, listed below, did not file their financial statements. They were automatically deregistered on March 26, 2012, together with all of the constituency associations on the old boundaries, upon proclamation of the new boundaries. Section Two – The 2012 Provincial General Election

Overview

The campaign period for the 2012 Provincial General Election commenced with the Writ of Election on March 26, 2012 and ended June 23, 2012, two months after polling day. Financial statements for the campaign period were required to be filed with the Chief Electoral Officer in accordance with Section 43 of the *EFCDA*. Four hundred thirty-one candidates were required to submit a 2012 Candidate Financial Statement on or before August 23, 2012, and nine political parties were required to submit a 2012 Political Party Campaign Period Financial Statement on or before October 23, 2012.

Failure to File the Candidate Financial Statement

Of the 431 candidates, 418 filed in a timely manner. Thirteen candidates failed to submit the required Candidate Financial Statement by the filing deadline. The names of these candidates and their chief financial officers (CFOs), along with the electoral division and political party affiliation, follow:

The Chief Electoral Officer transmitted a report to the Speaker of the Legislative Assembly on October 18, 2012 containing the names of the thirteen candidates and CFOs who did not comply with the filing requirements set out in the law. All those named in the report were notified in writing that, effective on the date the Speaker laid the report before the Legislative Assembly, they would be prohibited from being nominated as a candidate at a future provincial election for up to eight years. Further, the candidate's CFO would be prohibited from being the CFO for a political party, constituency association, candidate or third party for up to eight years.

The report was tabled before the Legislative Assembly on October 23, 2012. The thirteen named candidates and CFOs were notified that they could apply to the Court of Queen's Bench for relief within 60 days of the report being tabled.

Applications for Relief to the Court of Queen's Bench

Ten of the required financial statements were filed late, as listed below. The prohibition for these individuals has been reduced to five years from the date of filing their statements, except where applications for relief have been granted by the Court.

Campaign Deficits

Under Section 43.1 of the *EFCDA*, candidates who report a campaign deficit must retire that deficit and report on the manner by which it is retired. Nineteen candidates filed deficit campaign financial statements, and were automatically subject to a three-month campaign period extension beginning from the filing deadline of August 23, 2012 until November 23, 2012. During this time frame, candidates were permitted to accept additional contributions or transfers within prescribed limits, and in accordance with the legislation, for the purpose of eliminating the deficit. If the deficit was eliminated by November 23, 2012, an amended financial statement reporting the additional revenue was due on or before December 23, 2012. Eleven candidates met the filing requirement.

In accordance with Section 43.1(4), five candidates who applied to the Chief Electoral Officer and were granted an extension, had an additional three months, to February 23, 2013, to eliminate the deficit. The required financial statements were due on or before March 23, 2013. Further details are contained in Section Five of this report.

Failure to file amended financial statements showing the elimination of a campaign deficit may result in a candidate being prohibited from being nominated as a candidate at a future provincial election for up to eight years. Further, the candidate's CFO may be prohibited from being the CFO for a political party, constituency association, candidate or third party for up to eight years.

Section Three – The 2012 Senate Nominee Election

Overview

The campaign period for the 2012 Senate Nominee Election commenced with the Writ of Election on March 26, 2012 and ended June 23, 2012, two months after polling day. Financial statements for the campaign period were required to be filed with the Chief Electoral Officer in accordance with Section 43 of the *EFDA*. Thirteen candidates were required to file a Candidate Financial Statement on or before August 23, 2012, while the three political parties that nominated candidates were required to file a Political Party Campaign Period Financial Statement by October 23, 2012.

Campaign Deficits

Under Section 43.1 of the *EFDA*, candidates who report a campaign deficit must retire that deficit and report on the manner by which it is retired. One candidate filed a deficit campaign financial statement, and was automatically subject to a three-month campaign period extension beginning from the filing deadline of August 23, 2012 until November 23, 2012. A revised financial statement was received prior to December 23, 2012, reporting that the deficit had been eliminated.

Financial Statement Information

Political Parties – Campaign Period Financial Statements

The three political parties that nominated candidates for the 2012 Senate Nominee Election were required to submit an audited 2012 Political Party Campaign Period Financial Statement for the Senate Nominee Election. The Green Party of Alberta, Progressive Conservative Association of Alberta, and Wildrose Alliance Party all filed by the deadline.

Section Four – 2012 Third Party Election Advertising

Third parties were required to file a 2012 Third Party Election Period Advertising Report, including a financial statement, with the Chief Electoral Officer on or before October 23, 2012, in accordance with Section 44.9 of the *EFCEA*.

Section Five – General Information

Funds Held in Trust by the Office of the Chief Electoral Officer

On December 31, 2012, the Chief Electoral Officer held no funds in trust and had transferred no funds to the General Revenue Fund during 2012. In accordance with Section 10(12) of the *EFCDA*, any funds held in trust must be transferred to the General Revenue Fund for the Province of Alberta after one year.

Public Files and Reports

Public Files are maintained at the Office of the Chief Electoral Officer and contain information concerning political financing of registered political organizations in Alberta. The Public Files now contain data for thirty-six consecutive calendar years including ten provincial general elections starting March 14, 1979, nineteen by-elections held starting November 21, 1979 and four Senate Nominee elections held in 1989, 1998, 2004 and 2012.

Copies of financial statements are contained in the Public Files and are available for examination from 8:15 a.m. to 12:00 p.m. and 1:00 p.m. to 4:30 p.m., Monday to Friday. Photocopies of data maintained in the Public Files are available at a rate prescribed under authority of Section 11 of the *EFCDA*.

For ease of access throughout the province, copies of financial statements from 2004 onward, along with redacted lists of contributors, are available on the Elections Alberta website at: www.elections.ab.ca under the Financial Disclosure tab.

Reports published by the Chief Electoral Officer are available to the public at no cost and are also available on the Elections Alberta website.

Events of Interest during the 2012 Calendar Year

Elections Alberta provides ongoing support for political entities as compliance through education is an important goal of this Office. During 2012, there was a significant increase in the volume of inquiries related to the effects of the electoral division boundary changes, the General and Senate Nominee elections, third parties, legislative amendments, and prohibited contributions. The following highlights some of the significant activities and events during the 2012 calendar year.

Campaign Colleges

Elections Alberta offered to provide information relevant to political parties' campaign teams prior to the start of the election period. Elections Alberta provided this to three political parties, upon request.

In addition, Elections Alberta organized three open information sessions in Edmonton, Calgary, and Red Deer in early 2012. These open sessions were attended by approximately 400 candidates, chief financial officers, official agents and other political party representatives. The sessions were designed to provide participants with a better understanding of the provisions relating to registration requirements, contribution limits, issuing of official contribution receipts, restrictions on spending activities, advertising, filing of nomination papers, and filing of financial statements.

Amendments to the *EFCD* Pursuant to the *Election Statutes Amendment Act, 2010*

Pursuant to sections of the *Election Statutes Amendment Act, 2010*, a number of amendments to the *EFCD* came into force on March 26, 2012 with the issuance of the writs for the 2012 Provincial General Election. An overview of these amendments follows. Updated forms, guides and other resources were prepared by Elections Alberta and provided to political entities, to reflect the amendments.

Amendments to the *EFCDA* Pursuant to the *Election Accountability Amendment Act, 2012*

Bill 7, the *Election Accountability Amendment Act, 2012* (the *Act*), received Royal Assent on December 10, 2012. While the *Act* amended the *Election Act*, *Senatorial Selection Act*, and *EFCDA*, amendments to the *EFCDA* had an immediate impact on political parties and constituency associations.

Highlights of the significant amendments affecting political entities appear in the following chart. The chart provides a brief overview only, therefore it is important to review the legislation governing elections and election finances in their entirety. Events of Interest since January 1, 2013

The following activities and events occurred between the end of the 2012 calendar year and the date this report was published. Additional details will be provided in the 2013 Annual Report of the Chief Electoral Officer.

Highlights of the *EFDA* Amendments

Further to the significant amendments to the *EFDA* consequential to the passage of the *Election Accountability Amendment Act, 2012* (the *Act*) on December 10, 2012, Elections Alberta integrated the amendments into the forms, guides and other resources provided to political parties, constituency associations, candidates, leadership contestants, and third parties. As these resources are completed, they are made available through this Office and on the website at: www.elections.ab.ca.

Some of the more significant amendments are highlighted in this report.

Investigations

The *EFDA* was amended to increase openness and transparency into the financing of political entities. The amendments also expanded the regulatory powers of the Chief Electoral Officer in situations of non-compliance.

Provisions relating to the conduct and disclosure of investigations changed significantly in December 2012. The ability of the Chief Electoral Officer to apply sanctions was expanded to allow for the application of administrative penalties and letters of reprimand to recipients of prohibited contributions. Previously, those sanctions were limited to contributors.

Mandatory web-posting of the findings and decisions of investigations was enacted in December 2012 for those investigations in which administrative penalties were applied or letters of reprimand were issued. In addition, web-posting is authorized for investigations where no violation was found upon the written request of the complainant, the subject of the complaint or others involved in the matter. The legislative amendment allowed for retrospective public disclosure, in both cases, to include web-posting of violations that occurred on or after December 10, 2009.

Results of investigations that have concluded, and meet these criteria, appear on Elections Alberta's website.

As at December 31, 2012, 98 files had been opened in circumstances of possible violation of the *EFDA*, and 79 were concluded. Findings and decisions relating to the 45 files which were found to demonstrate violations that had occurred on or after December 10, 2009 appear on the website.

Files containing evidence of violations are divided into two categories: direct and indirect.

A direct contribution is one in which:

- a prohibited corporation makes a contribution to a political entity
- a contributor makes an unauthorized contribution or over-contribution to a political entity

An indirect contribution is one in which:

- an individual or organization makes a contribution and is later reimbursed by a prohibited corporation

As at December 2012, 24 violations were a result of direct contributions and 21 were a result of indirect contributions. Educational resources for both contributors and recipients are available, reflecting the current statutory framework, to increase the understanding of all stakeholders and promote compliance through education. Resources have been developed to support contributors and chief financial officers, since both have specific obligations with respect to compliance.

The *EFCD*A allows the Chief Electoral Officer to order political entities to return the full amount of prohibited contributions that were received on or after April 22, 2010. Political entities were encouraged to return prohibited contributions received prior to that date on a voluntary basis. Return of these prohibited contributions ensures that political entities do not take the benefit of prohibited contributions even in circumstances where the political entity itself may not have contravened the legislation. In a number of cases, political entities have returned prohibited contributions upon determining that they were made in violation of the *EFCD*A, and have self-reported the circumstances to the Chief Electoral Officer. Information concerning the ordered or voluntary return of prohibited contributions appears on the website.

Quarterly Reporting

In accordance with Section 32(3) of the *EFCD*A, beginning January 1, 2013 all political parties and constituency associations are required to file quarterly reports in addition to the annual financial statements which must be filed with Elections Alberta. This increases the financial filings submitted to this Office in any calendar year from approximately 400 to 2,000. The quarterly reporting requirement was consequential to the passage of the *Act* on December 10, 2012.

Quarterly reporting is based on each three-month period of the calendar year (January 1 to March 31, April 1 to June 30, July 1 to September 30, and October 1 to December 31), with a filing deadline fifteen days after the end of the quarter. Quarterly reports are limited to the submission of contribution information, which must include the contributor name, address and total contribution amount for contributions over \$250 received in the quarter, and the total of all contributions up to \$250 received in the quarter.

Quarterly reports are disclosed on the Elections Alberta website at: www.elections.ab.ca as submitted by the political parties and constituency associations.

In order to avoid the need for completion and transmission of hard copy (paper) forms for quarterly reporting, a user-friendly online application was developed by Elections Alberta and launched on April 2, 2013. At the date of publication of this report, 98% of quarterly reports are being submitted using the online tool, while 2% are submitted on paper forms.

Elections Alberta has designated staff to provide ongoing support to political parties and constituency associations in order to facilitate timely and accurate quarterly reporting. This support, the online application and user instructions were developed to assist political entities in fulfilling this new statutory obligation. To date, compliance was over 97% and reached 100% by the third quarter.

Leadership Contests

Elections Alberta is responsible for maintaining oversight of political party leadership contests, consequential to the passage of the *Act* on December 10, 2012.

Elections Alberta's responsibilities include the management of registration, reporting and disclosure of leadership contests. Political parties are responsible for receiving and reviewing the registration applications and for endorsing eligible leadership contestants. Leadership contestants are responsible for appointing an eligible chief financial officer (CFO), who must ensure compliance with all aspects of campaign finance including the filing of Leadership Contestant Financial Statements. A "Guide to the Election Finances and Contributions Disclosure Act for Leadership Contestants" has been created and is available on the Elections Alberta website at: www.elections.ab.ca. A guide for contributors is also available to complement the leadership contestant guide.

The Alberta Party filed a statement with the Chief Electoral Officer setting out April 6, 2013 as the date of the official call of the leadership contest. Two leadership contestant registration applications were received by Nomination Day, August 12, 2013, and both were approved. A leadership vote was held on September 21, 2013. Financial statements are due on or before January 21, 2014. Additional details will be provided in the 2013 Annual Report of the Chief Electoral Officer.

Campaign Deficit Retirement

Under Section 43.1 of the *EFCD*, candidates who report a campaign deficit must retire that deficit and report on the manner by which it is retired.

Of the nineteen candidates who filed deficit campaign financial statements, sixteen candidates met the filing requirements, including candidates who were granted a three-month extension to eliminate the deficit.

Three candidates failed to submit amended financial statements indicating that the deficit had been eliminated. The names of these candidates and their CFOs, along with the electoral division and political party affiliation, follow:

The Chief Electoral Officer transmitted a report to the Speaker of the Legislative Assembly on May 6, 2013 containing the names of the three candidates and CFOs who did not comply with the deficit elimination requirements. All those named in the report were notified in writing that, effective on the date the Speaker laid the report before the Legislative Assembly, they would be prohibited from being nominated as a candidate at any future provincial election for up to eight years. Further, the CFOs would be prohibited from being the CFO for a political party, constituency association, candidate or third party for up to eight years.

The report was tabled before the Legislative Assembly on May 7, 2013. The three named candidates and CFOs were notified that they could apply to the Court of Queen's Bench for relief within 60 days of the report being tabled. None of the candidates nor CFOs applied.

At the date of publication of this annual report Allan Hunsperger, candidate, filed the required statement. Therefore, the prohibition for the candidate and Pamela Misner, CFO, has been reduced to five years from the date of filing the required statements.

Political Party Name and Abbreviation Changes

The Wildrose Alliance Party requested that the political party abbreviation is to be shown in election documents as "WRP", which became effective January 8, 2013.

The Separation Party of Alberta (SPA) made application to change the political party name to Alberta First Party (AFP). The request was approved and the change was made effective May 14, 2013.

Section Six – Recommendations

Recommendations for Legislative Amendments

Consequential to the passage of the *Election Accountability Amendment Act, 2012* (the *Act*) on December 10, 2012, recommendations for amendments to the *EFDA* are included in this report. It should be noted that the *EFDA* has been amended numerous times over the past 36 years, but never rewritten. It may benefit from being modernized to reflect the style that is evident in most statutes in use today.

1. Designation of Publicly Funded Corporations as Prohibited Corporations (Section 3)

Currently, there are several different groups of corporations that are prohibited from making political contributions. These groups of prohibited corporations include municipalities, school boards, post-secondary institutions, and Provincial corporations. In addition, the authority exists to identify publicly funded corporations by regulation.

Recommendation

Create the regulation to establish what constitutes a publicly funded corporation. A regulation identifying publicly funded corporations would enhance clarity, understanding and, ultimately, compliance on the part of contributors, recipients and the public.

2. Initiation of Investigation (Section 4(1)(b.1))

An investigation may be initiated by the Chief Electoral Officer or at the request of another person or organization. Investigations may require a significant commitment of staff and monetary resources and should not be conducted on the basis of an anonymous or vague complaint.

Recommendation

Prescribe that the complainant must provide a written request to initiate an investigation. This will allow the Chief Electoral Officer to obtain additional information from the complainant, where necessary, for the efficient management of the investigation. It will also allow the Chief Electoral Officer to provide appropriate notice to the complainant, as required by the *EFDA*. In addition, it will avoid the dedication of investigative resources to anonymous or vague complaints that may be unfounded or vexatious.

3. Power of the Chief Electoral Officer to Compel Documents (Section 5(3))

The Chief Electoral Officer must have access to relevant documentation from all relevant sources to allow for investigation into allegations of prohibited contributions. While political entities are required to provide documents related to their financial affairs, contributors are not.

Recommendations

Expand on the documentation that may be compelled from political entities by the Chief Electoral Officer in the conduct of an investigation, to allow for the review of all relevant documentation.

Add contributors to the list of those persons and organizations compelled to provide documentation that is requested by the Chief Electoral Officer in the conduct of an investigation.

4. Public Disclosure of Orders issued by the Chief Electoral Officer (Section 5.2(3)(a))

Findings and decisions of the Chief Electoral Officer are web-posted upon the conclusion of investigations when administrative penalties are imposed or letters of reprimand are issued. There is no specific direction with respect to the web-posting of orders issued for the return of prohibited contributions to the contributors.

Recommendation

Add specific direction for the web-posting of orders issued for the return of prohibited contributions to expand the disclosure of remediation following the investigative process. Prescribing broader disclosure will illuminate the steps taken to ensure that political entities do not take the benefit of prohibited contributions and will serve to maintain stakeholders' confidence in the integrity of the political financing process.

5. Public Disclosure of the Results of Investigations (Section 5.2(3)(b))

Findings and decisions of the Chief Electoral Officer are web-posted upon the conclusion of investigations when administrative penalties are imposed or letters of reprimand are issued. If it is determined that no violation has occurred, web-posting occurs upon the written request of the complainant, the subject of the complaint or other persons or organizations involved in the matter. This could result in an unfounded allegation being web-posted at the request of the complainant who initiated the complaint.

Recommendation

In cases where no violation is found, limit the authority to request web-posting of investigation results to the subject of the complaint. This will avoid unwanted public attention to an unfounded or frivolous allegation that may potentially have a negative impact on the subject of the complaint.

6. Candidate Registration (Section 9(2)(a)(iv))

A candidate endorsed by a political party may be included in the register of candidates upon nomination by a constituency association. A candidate with no political affiliation (an independent candidate) may only be included in the register of candidates after the issuance of a writ of election. This provides candidates who are endorsed by a political party with the ability to commence fundraising activities before independent candidates are able to do so.

Recommendation

Allow candidates with no political affiliation to be included in the register of candidates within the campaign period. With a fixed election period, the campaign period commences on February 1. This will allow independent candidates to register and commence fundraising activities in advance of the issuance of the Writ, to allow for more equitable treatment of all candidates.

7. Contributions from Estates (Section 17)

There is no specific provision that clarifies the law with respect to contributions from testamentary estates.

Recommendation

Add testamentary estates containing specific bequests to political entities to the listing of eligible contributors. Allow for contributions from the estate of a decedent who was eligible at the time of death to be made over a period of time, within existing annual and campaign contribution limits. This would enhance clarity with respect to the eligibility of these contributions.

8. Increase Allowable Payroll Deductions (Section 26(1))

The limit on monthly payroll deductions by members of a trade union or employee organization that are not deemed to be contributions has not been updated since 1982.

Recommendation

Increase the allowable limit to adjust for inflationary effects.

9. Penalty for Failing to File a Deficit Retirement Statement (Sections 44(1), 48)

A candidate who fails to eliminate a campaign deficit is subject to sanctions under the *EFCD*A, and may lose his or her ability to act as a candidate for up to 8 years. No such penalty, or offence provision, exists for failing to file a deficit retirement statement.

Recommendations

Penalize candidates who fail to file a deficit retirement statement in the same manner as those who fail to file a campaign financial statement, by prohibiting their participation as candidates for up to 8 years.

Include an offence provision for candidates who fail to comply with deficit retirement filing requirements that is consistent with the provision for failing to file a campaign financial statement.

10. Application of Third Party Advertising to By-elections (Section 44.1)

Third party advertising provisions currently apply to general elections, but not to by-elections.

Recommendation

Extend third party advertising provisions to include by-elections for consistency in the disclosure of this important information.

11. Contributions not Belonging to a Contributor (Section 44.51(1))

Persons have been omitted from the listing of those prohibited from giving funds to a person, corporation, trade union or employee organization for the purpose of making an election advertising contribution with funds that do not belong to the contributor.

Recommendation

Expand the listing throughout Section 44.51 to include persons, along with corporations, trade unions and employee organizations.

12. Deficit Reporting by Third Party Advertisers (Section 44.92)

Third parties are required to report on the disposition of surplus funds held at the end of an election period, but are not required to account for the elimination of a deficit. This limits disclosure and creates uncertainty with regard to the eligibility of the contribution(s) made to eliminate the deficit.

Recommendation

Require third parties to report on the manner in which a deficit was eliminated to enhance openness and transparency.

13. Deficit Reporting by Leadership Contestants (Section 44.96)

There is no provision requiring a leadership contestant to account for the elimination of a deficit that exists at the end of the campaign period. This limits disclosure and creates uncertainty with regard to the eligibility of the contribution(s) made to eliminate the deficit.

Recommendation

Require leadership contestants to report on the manner in which a deficit was eliminated to enhance openness and transparency.

14. Third Party Offence Provisions (Section 49.1)

Currently, there are no offence provisions for failing to register as a third party.

Recommendation

Include an offence provision for third parties who fail to register to allow for enforcement of registration requirements.

NOTES TO THE FINANCIAL STATEMENTS

Note 1 Authority

The Office of the Chief Electoral Officer (the “Office”) is operated under the authority of the *Election Act*, the *Election Finances and Contributions Disclosure Act* and the *Senatorial Selection Act*. The net cost of the operations of the Office is borne by the General Revenue Fund of the Province of Alberta. Annual operating budgets are reviewed by the Select Standing Committee on Legislative Offices.

Note 2 Purpose

The Chief Electoral Officer provides administrative, logistic and financial support for general and special enumerations, general elections and by-elections, and plebiscites in support of the *Election Act* and elections in support of the *Senatorial Selection Act*. The Chief Electoral Officer monitors and records the financial activities of registered parties, constituency associations and candidates to ensure compliance with the *Election Finances and Contributions Disclosure Act*.

Note 3 Summary of Significant Accounting Policies and Reporting Practices

These financial statements are prepared in accordance with Canadian public sector accounting standards.

a) Reporting Entity

The reporting entity is the Office of the Chief Electoral Officer, for which the Chief Electoral Officer is responsible.

The Office operates within the General Revenue Fund (the “Fund”). The Fund is administered by the Minister of Finance and Enterprise. All receipts of the Office are deposited into the Fund and all disbursements made by the Office are paid from the Fund.

Note 3 Summary of Significant Accounting Policies and Reporting Practices (continued)

b) Basis of Financial Reporting

Revenues

All revenues are reported on the accrual basis of accounting.

Expenses

Expenses represent the costs of resources consumed during the year on the Office's operations.

Pension costs included in these statements comprise the cost of employer contributions for current service of employees during the year.

Assets

Financial assets of the Office are limited to financial claims such as advances to and accounts receivables from other organizations, employees and other individuals.

Tangible capital assets of the Office are recorded at historical cost. The threshold for capitalizing capital assets is \$5,000. Amortization is calculated on a straight-line basis, over the estimated useful lives of the assets as follows:

Computer hardware and software	3 years
Warehouse Equipment	10 years
Furniture and other office equipment	10 years
Election assets	20% each general election

In the year of addition and disposal, amortization is one-half of the prescribed amounts.

Prepaid Expenses

Returning Officer Offices were paid for the month of April 2012 to secure locations for the General Election, held April 23, 2012.

Liabilities

Liabilities represent all financial claims payable by the Office at fiscal year end.

Note 3 Summary of Significant Accounting Policies and Reporting Practices (continued)

Net Assets/ Net Liabilities

Net assets/liabilities represent the difference between the value of assets held by the Office and its liabilities. Canadian public sector accounting standards require a "net debt" presentation for the statement of financial position in the summary financial statements of the governments. Net debt presentation reports the difference between financial assets and liabilities as "net debt" or "net financial assets" as an indicator of the future revenues required to pay for past transactions and events. The office operates within the government reporting entity, and does not finance its expenditures by independently raising revenues. Accordingly, these financial statements do not report a net debt indicator.

Valuation of Financial Assets and Liabilities

Fair value is the amount of consideration agreed upon in an arm's length transaction between knowledgeable, willing parties who are under no compulsion to act.

The fair value of cash, accounts receivable and advances, accounts payable and accrued liabilities are estimated to approximate their carrying values.

Note 5 Benefit Plans

The Office participates in the multi-employer pension plans: Management Employees Pension Plan and Public Service Pension Plan. The Office also participates in the multi-employer Supplementary Retirement Plan for Public Service Managers. The expense for these pension plans is equivalent to the annual contribution of \$195,580 for the year ended March 31, 2013 (2012 - \$180,550).

At December 31, 2012, the Management Employees Pension Plan reported a deficiency of \$303,423,000 (2011 deficiency - \$517,726,000) and the Public Service Pension Plan reported a deficiency of \$1,645,141,000 (2011 - deficiency of \$1,790,383,000). At December 31, 2012, the Supplementary Retirement Plan for Public Service Managers had a deficiency of \$51,870,000 (2011 - deficiency of \$53,489,000).

The Office also participates in two multi-employer Long Term Disability Income Continuance Plans. At March 31, 2013, the Bargaining Unit Plan reported an actuarial surplus of \$51,717,000 (2012 - \$9,136,000) and the Management, Opted Out and Excluded Plan an actuarial surplus of \$18,327,000 (2012 - \$10,454,000). The expense for these two plans is limited to the employer's annual contributions for the year.
