## GENERAL SUMMARY

THE VACANCY IN THE ELECTORAL DIVISION OF BARRHEAD WAS CAUSED BY THE RESIGNATION OF THE HON. DR. HUGH M. HORNER, ON OCTOBER 1ST, 1979.

BY ORDER OF THE LIEUTENANT GOVERNOR IN COUNCIL, A WRIT OF ELECTION DATED OCTOBER 24TH, 1979, WAS ISSUED BY THE CHIEF ELECTORAL OFFICER TO MRS. MARGE PICKRELL, RETURNING OFFICER, PURSUANT TO SECTION 4 OF THE ELECTION ACT.

NOMINATION DAY WAS NOVEMBER 7TH, 1979, AND POLLING DAY WAS NOVEMBER 21ST, 1979.

FOUR CANDIDATES, EACH REGISTERED UNDER THE ELECTION FINANCES AND CONTRIBUTIONS DISCLOSURE ACT, WERE NOMINATED TO CONTEST THE BY-ELECTION.

ADVANCE POLLS WERE HELD IN THREE LOCATIONS ON NOVEMBER 15TH, 16TH AND 17TH, 1979, AND TREATMENT CENTRE POLLING WAS CONDUCTED ON NOVEMBER 21ST, 1979.

THE RETURNING OFFICER'S RETURN TO THE WRIT OF ELECTION AFTER COMPLETION OF THE OFFICIAL COUNT, DECEMBER 1ST, 1979, CERTIFIED THAT KEN KOWALSKI, PROGRESSIVE CONSERVATIVE, WAS DULY ELECTED.


NO APPEALS FOR A JUDICIAL RECOUNT WERE APPLIED FOR PURSUANT TO SECTION 105 OF THE ELECTION ACT.

THE CHIEF ELECTORAL OFFICER PUBLISHED THE BY-ELECTION RETURN IN THE ALBERTA GAZETTE, DATED DECEMBER 15, 1979.

NOMINATION DEPOSITS WERE FORFEITED BY TWO OF THE CANDIDATES AND THE FORFEITED AMOUNT OF \$200 HAS BEEN PAID THROUGH THE CHIEF ELECTORAL OFFICER TO THE PROVINCIAL TREASURER FOR DEPOSIT TO THE GENERAL REVENUE ACCOUNT.

THE OFFICIAL RESULTS BY CANDIDATE AND THE STATEMENT OF VOTE BY POLL ARE DISPLAYED ON PAGES 3 THROUGH 5.

THE TOTAL COST TO CONDUCT THE BY-ELECTION WAS \$18,022. A COST SUMMARY IS SHOWN ON PAGE 5.
